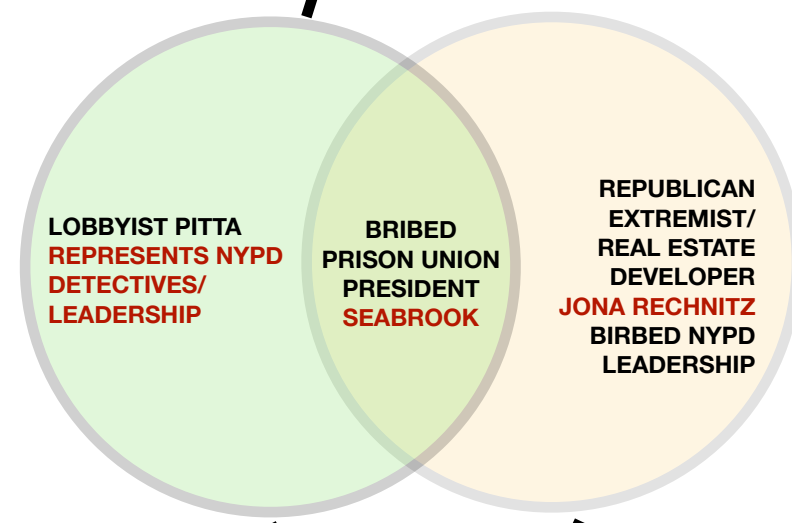


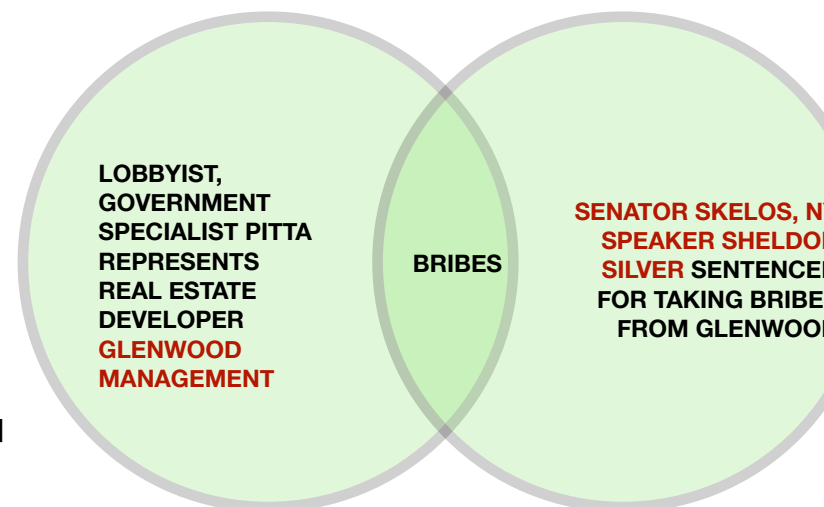
ICD-9 MR317

GENETIC MENTAL RETARDATION BILLING CODE ICD-9 MR317 is the unmistakable thread and criminal fraud that set into motion the following egregious, stupid, RICO conspiracy so that Republican Judge Edward Smith could apply for federal judge. Parties' criminal guilt is exemplified by their strenuous concealment of ICD-9 MR317. Defendants were given many opportunities to come forward from 2006 to 2011, to report their use of ICD-9 MR317 to SELL a normal student [my daughter] to a special education contractor in court documentation but never did. Instead, they skirted around interrogatories, [spoiled ESI](#), and used extreme violent witness suppression. THE CHART picks up after the close of Kraemer v. Pennsylvania. Defendants, 9 Court officers, and 4 executive level public officials, including PA AG Linda Kelly, lied to the Delaware U.S. attorney concealing Judge Smith's approval of ICD-9 MR317 to sell a normal minor to a special education employment contractor.



LOBBYIST PITTA, BISHOP & DEL GIORNO LLC AND REPUBLICAN EXTREMIST/FOREIGN AGENT JONA RECHNITZ worked together to achieve common goals. Both used their influence over NYPD to help Republican judge Edward Smith become federal judge via NYPD omission of duty allowing violence, extortion and robbery of his victims. Analogous to that is 12/11/2014 after Prison union President Martin Seabrook took \$60,000 in bribes from **Rechnitz and Reichberg** to invest retirement funds with Platinum Partners—01/2015 Seabrook dropped lobbyist Justin McCarthy Consulting LLC and retained **Pitta & Bishop LLC** for double [\$90,000] what he was previously paying. This has the same **Rechnitz/Pitta** common interest corollary as my being forced from my apartment with toxic fumes and infestation 11/04/2013 [after NYPD McGinn's promotion instigated by **Rechnitz** who was bribing NYPD] and 11/06/2013 [while **Republican Judge Ed Smith** was before the U.S. Senate Judiciary Committee for a hearing] I was attacked by **Hotel Trades Council** members represented by **Pitta** in hotels that I retained after being forced out. A pattern of lobbyist/government specialist Pitta's clients either soliciting bribes or taking bribes. In real estate developer Glenwood Management's case, Pitta's long standing client was bribing NY Assembly Speaker Sheldon Silver, Pitta routinely had legislation business before.
